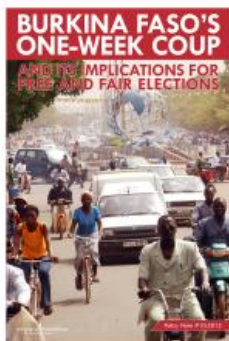

Burkina Faso's one-week coup



In the upcoming elections in Burkina Faso, there's a need for a clear democratic break with the three decades of de facto one-party rule. At the same time, a moderate approach is needed in dealing with the controversial legacy of the former regime, to avoid further polarisation in an already fraught political situation. These are the recommendations of NAI researchers Jesper Bjarnesen and Cristiano Lanzano in a policy note on Burkina Faso's one-week coup and its implications for free and fair elections.

Many countries in sub-Saharan Africa have recently experienced remarkable growth. Afro-optimists claim that economic transformation is imminent, while critics point out that growth is mainly in the extractive sectors, with little improvement being noted among the rural and urban poor. In this volume, the authors review the varied challenges agricultural producers have faced in the past and may well face today and tomorrow. Several contributions focus on the drive for large-scale land acquisitions, their potential and shortcomings, as well as on the policy alternative – investment in small-scale farming.
